

Purpose of Contract: The purpose of this contract is to preapprove vendors for tree trimming, palm and shrub removal, for Maintenance Operations.

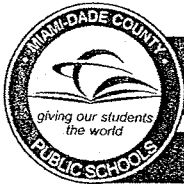
