

Purpose of Contract: The purpose of this contract is to provide on-site comprehensive healthcare services, to approximately 280 teen parents and their infants/toddlers at C.O.P.E. Center North, and approximately 175 teen parents and their infants/toddlers at Dorothy M. Wallace C.O.P.E. Center South.

Terms of Contract Award and Extension: One (1) year, with an option to extend for two (2) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.




