Purpose of Contract: The purpose of this contract is to establish a pool of pre-qualified vendors, to furnish wireless networking technology, for Information Technology Services.

Terms of Contract Award and Extension: Twenty-seven (27) months, with an option to extend for three (3) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service.
