

## **CONTRACT EXTENSION SUMMARY**

Contract No.: 044-KK10

Contract Title: OUTSIDE AGENCIES QUALIFIED TO OPERATE ALTERNATIVE PROGRAMS FOR MIAMI-DADE COUNTY PUBLIC SCHOOLS AT-RISK STUDENTS

Board Meeting Date: August 4, 2010- Agenda Item C-11

Purpose of Contract: The purpose of this contract is to provide services to at-risk and/or adjudicated school-age youth, in grades 6-12, within Miami-Dade County, Florida, for the Educational Alternative Outreach Program (EAOP)/School Operations.

Initial Award Amount: \$2,794,724

Initial Contract Award Period and Extension: August 4, 2010 – July 31, 2011  
One (1) year, with an option to extend for two (2) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$2,794,724

Current Extension Period: August 1, 2011 – July 31, 2012

Recommended Extension Award Amount: \$1,413,621

Recommended Extension Period: August 1, 2012 – July 31, 2013  
This is the second extension of the contract. The awardees have agreed to extend for an additional one (1) year period, by letter, on file.
