

Contract Title: STATE LEGISLATIVE CONSULTANT

Board Meeting Date: June 13, 2010 – Agenda Item E-143

Purpose of Contract: The purpose of this contract is to provide state legislative consulting services for The School Board of Miami-Dade County, Florida.

Initial Award Amount: \$240,000

Initial Contract Award Period and Extension: January 13, 2010 – January 12, 2011  
One (1) year, with an option to extend for three (3) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$240,000

Current Extension Period: January 13, 2012 – January 12, 2013

Recommended Extension Award Amount: \$240,000

Recommended Extension Period: January 13, 2013 – January 12, 2014  
This is the third extension of the contract. The awardees have agreed to extend for an additional one (1) year period, by letter, on file.
