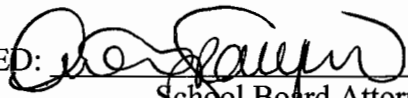
SUBJECT: SUPERINTENDENT'S EXTENSION OF CONTRACTS

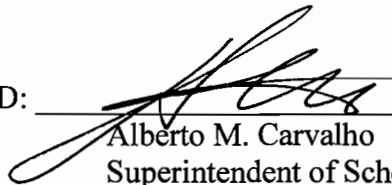

CONTRACT EXTENSION SUMMARY

Contract No.: 039-JJ10

Contract Title: SIGN-LANGUAGE INTERPRETATION SERVICES

Board Meeting Date: January 14, 2009 – Agenda Item E-146

Purpose of Contract: The purpose of this contract is to purchase, at firm unit prices, quantities, as may be required, of sign-language interpretation services, for the hearing impaired, for The School Board of Miami-Dade County, Florida.

Initial Award Amount: \$160,000

Initial Contract Award Period and Extension: January 14, 2009 – January 13, 2011
Two (2) years, with an option to extend for an additional two (2) year period and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$160,000

Current Extension Period: January 14, 2011 – January 13, 2013

Recommended Extension Award Amount: \$96,250

Recommended Extension Period: January 14, 2013 – April 13, 2013
This is the final extension of the contract. The awardee has agreed to extend for an additional ninety (90) day period, by letter, on file.

Vendors Recommended for Contract Extension: One (1)

Accessible Communication for the Deaf

Cost Savings: No

Justification: It is considered to be in the best interest of the District to extend this contract for an additional ninety (90) day period, to benefit from fixed prices and continuity of service. Staff has indicated satisfactory performance from the vendor and recommends extension.
