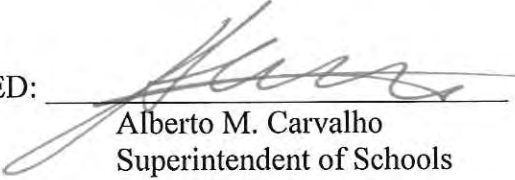

CONTRACT EXTENSION SUMMARY

Contract No.: 007-JJ11

Contract Title: ON-SITE SERVICE FOR TELEPHONE EQUIPMENT

Board Meeting Date: December 10, 2008 – Agenda Item E-144

Purpose of Contract: The purpose of this contract is to purchase, at firm unit prices, materials, installation and service for telephone equipment, for Miami-Dade County Public Schools.

Initial Award Amount: \$10,000,000

Initial Contract Award Period and Extension: July 1, 2009 – September 30, 2011
Twenty-seven (27) months, with an option to extend for three (3) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$1,138,357

Current Extension Period: October 1, 2012 – September 30, 2013

Recommended Extension Award Amount: \$1,138,357

Recommended Extension Period: October 1, 2013 – September 30, 2014
This is the third extension of the contract. The awardee has agreed to extend for an additional one (1) year period, by letter, on file.

Vendors Recommended for Contract Extension: One (1)

XETA Technologies, Inc.

Cost Savings: No

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of October 2012, indicated an increase of 0.1% with an annual index of 2.2%. Staff has indicated satisfactory performance from the vendor and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the School Board.

Benchmark: Inasmuch as the contracts awarded by The School Board of Broward County, Florida, GSA, and the Florida Department of Management are structured differently than M-DCPS, benchmarking cannot be conducted.
