CONTRACT EXTENSION SUMMARY

Contract No.: 046-KK10

Contract Title: SPEECH AND LANGUAGE PATHOLOGY SERVICES

Board Meeting Date: June 16, 2010 – Agenda Item C-13

Purpose of Contract: The purpose of this contract is to provide speech and language pathology services, for the education of disabled students, for whom such services have been identified as necessary to access education, for the Office of Professional Development and Educational Services.

Initial Award Amount: \$2,000,000

Initial Contract Award Period and Extension: July 1, 2010 – June 30, 2012
Two (2) years, with an option to extend for two (2) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$1,000,000

Current Extension Period: July 1, 2012 – June 30, 2013

Recommended Extension Award Amount: \$300,000

Recommended Extension Period: July 1, 2013 – September 30, 2013
This is the final extension of the contract. The awardees have agreed to extend for an additional ninety (90) day period, by letter, on file.

Vendors Recommended for Contract Extension: Two (2)

Cost Savings: No
