CONTRACT EXTENSION SUMMARY

Contract No.: 041-LL06

Contract Title: FENCE-LINE AND LOT MAINTENANCE, NORTH AND SOUTH OF FLAGLER STREET

Board Meeting Date: June 15, 2011 – Agenda Item F-62

Purpose of Contract: The purpose of this contract is to purchase, at firm unit prices, quantities, as may be required, of fence-line and lot maintenance, tractor mowing, mechanical clearing and collection, removal and proper disposal of bulk trash and debris, as needed, for Miami-Dade County Public Schools facilities, sites and locations.

Initial Award Amount: \$586,776

Initial Contract Award Period and Extension: June 15, 2011 – June 14, 2012
One (1) year, with an option to extend for two (2) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$50,000

Current Extension Period: June 15, 2012 – June 14, 2013

Recommended Extension Award Amount: \$51,212

Recommended Extension Period: June 15, 2013 – June 14, 2014
This is the second extension of the contract. The awardees have agreed to extend for an additional one (1) year period, by letter, on file.

Vendors Recommended for Contract Extension: Two (2)

Superior Landscaping & Lawn Service, Inc. – M/WBE
Florida Garden Center Corporation

Cost Savings: No

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of May 2013, indicated an increase of 0.1% with an annual index increase of 1.4%. Staff has indicated satisfactory performance from the vendors and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the School Board.

Benchmark: Benchmarking was conducted against the School Boards of Broward and Palm Beach Counties, however, since there were differences in the bid specifications, a price comparison could not be performed.
