Purpose of Contract: The purpose of this contract is to purchase, at firm unit prices, quantities, as

may be required, of factory-rebuilt transmissions, for the Department of

Transportation, Vehicle Maintenance.

Initial Award Amount: \$400,000

Initial Contract Award Period and Extension:

July 15, 2009 - July 31, 2011

Two (2) years, with an option to extend for three (3) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date

of the current contract period.

Current Extension Amount: \$140,000

Current Extension Period:

August 1, 2012 – July 31, 2013

Recommended Extension Award Amount: \$142,730

Recommended Extension Period: August 1, 2013 – July 31, 2014

This is the third extension of the contract. The awardee has agreed to extend for an additional one (1) year period, by letter, on file.

Vendors Recommended for Contract Extension: One (1)

Cost Savings: No ₹

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of May 2013, indicated an increase of 0.1% with an annual index increase of 1.4%. Staff has indicated satisfactory performance from the vendor and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the School Board.

Benchmark:

Benchmarking was conducted against The School Board of Broward County, Florida,

and the District's prices were found to be lower.
