Justification: It is considered to be in the best interest of the District to extend this contract for an

additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price index (CPI), as of September 2013, indicated an increase of 0.2% with an annual index increase of 1.2%. Staff has indicated satisfactory performance from the vendors and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the

School Board.

Benchmark:

Inasmuch as the contract awarded by The School Board of Broward County, Florida, and the School District of Palm Beach County are structured differently than Miami-
