Contract No.: 053-LL08

Contract Title: SCHOOL-BUS ROUTES FOR PRIVATE SCHOOL-BUS COMPANIES

Board Meeting Date: August 3, 2011 – Agenda Item E-142

Purpose of Contract: The purpose of this contract is to purchase, at a firm unit price, quantities, as may be required, of school-bus routes, for the Department of Transportation.

Initial Award Amount: \$5,461,400

Initial Contract Award Period and Extension: August 3, 2011 – September 2, 2013
Two (2) years, with an option to extend for three (3) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$2,675,000

Current Extension Period: August 3, 2013 – August 2, 2014

Recommended Extension Award Amount: \$2,346,840

Recommended Extension Period: August 3, 2014 – August 2, 2015
This is the second extension of the contract. The awardees have agreed to extend for an additional one (1) year period, by letter, on file.

Cost Savings: No Due to an increase in fuel and insurance prices, the vendors are unable to offer any cost reductions at this time.
