Contract Title: DISASTER DEBRIS REMOVAL MONITORING SERVICES

Board Meeting Date: June 15, 2011 – Agenda Item F-61

Purpose of Contract: The purpose of this contract is to support the oversight and management of debris removal contractors, during disaster response recovery, for Maintenance Operations.

Initial Award Amount: NA

Initial Contract Award Period and Extension: June 15, 2011 – June 14, 2012
One (1) year, with an option to extend for six (6) additional one (1) year period and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: N/A

Current Extension Period: June 15, 2014 – June 14, 2015

Recommended Extension Award Amount: N/A

Recommended Extension Period: June 15, 2015 – June 14, 2016
This is the fourth extension of the contract. The awardees have agreed to extend for an additional one (1) year period, by letter, on file.

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from continuity of service.
