




SUBJECT: SUPERINTENDENT'S EXTENSION OF CONTRACTS

CONTRACT EXTENSION SUMMARY

Contract No.: 060-NN10

Contract Title: SPEECH AND LANGUAGE PATHOLOGY SERVICES/SPEECH LANGUAGE EVALUATIONS

Board Meeting Date: September 3, 2013 – Agenda Item C-11

Purpose of Contract: The purpose of this contract is to provide speech and language evaluations to referred students and/or speech and language pathology services, for the education of students, for whom such services have been identified as necessary to access education, for the Division of Special Education Services.

Initial Award Amount: \$6,000,000

Initial Contract Award Period and Extension: October 1, 2013 – June 30, 2015

From October 1, 2013, through June 30, 2015, and may be extended for two (2) additional one (1) year periods; and if needed, an additional ninety (90) days beyond the expiration date of the current renewal period.

Current Extension Amount: \$3,000,000

Current Extension Period: July 1, 2015 – June 30, 2016

Recommended Extension Award Amount: \$1,750,000

Recommended Extension Period: July 1, 2016 – December 31, 2016

This is the second extension of the contract. The awardees have agreed to extend for an additional one (1) year period, by letter, on file.

Vendor(s) Recommended for Contract Extension: Two (2)


Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of March 2016, indicated an annual index increase of .09%. Staff has indicated satisfactory performance from the vendors and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the School Board.
