


SUBJECT: **SUPERINTENDENT'S EXTENSION OF CONTRACTS**

Contract Title: HVAC AND CONTROLS: REPLACE, SUPPLY AND/OR INSTALL

Board Meeting Date: August 6, 2014 – Agenda Item F-60

Purpose of Contract: The purpose of this ITB is to establish a list of preapproved vendors, to furnish all labor, supervision, equipment, and materials necessary, to repair/replace HVAC equipment, controls and related components, for Maintenance Operations

Initial Award Amount: \$6,000,000

Initial Contract Award Period and Extension: August 10, 2014 – August 9, 2015
Twelve (12) months, with an option to extend for one (1) additional one (1) year period and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$6,000,000

Current Extension Period: August 10, 2015 – August 9, 2016

Recommended Extension Award Amount: \$500,000

Recommended Extension Period: August 10, 2016 – November 9, 2016
This is the second extension of the contract. The awardees have agreed to extend for an additional ninety (90) days period, by letter, on file.

Cost Savings: No

Justification: It is considered to be in the best interest of the District to extend this contract for an additional ninety (90) days period, to benefit from continuity of service, inasmuch as the Consumer Price Index (CPI), as of May 2016, indicated an annual index increase of 0.2%. Staff has indicated satisfactory performance from the vendors and recommends extension. This extension is based on the terms and conditions contained in the original contract approved by the School Board.

Benchmark: Inasmuch as the contract awarded by The School Board of Broward County, Florida is structured differently than M-DCPS, and Miami-Dade County is using this M-DCPS contract for its services, benchmarking cannot be conducted.
