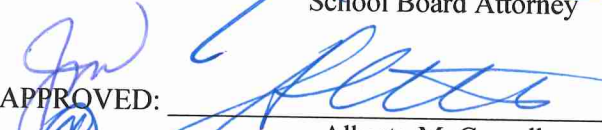

## CONTRACT EXTENSION SUMMARY

Contract No.: 072-NN03

Contract Title: Recycling and Solid Waste Collection Services

Board Meeting Date: September 3, 2013 Agenda Item: F-60

Purpose of Contract: The purpose of this bid is to provide, at a firm unit price, recycling and solid-waste collection services, for various Miami-Dade County Public Schools District locations.

Initial Award Amount: \$15,924,222

Initial Contract Award Period and Extension: October 1, 2013 – September 30, 2016 Three (3) years, with an option to extend for two (2) additional one (1) year periods.

Current Extension Amount: N/A

Current Extension Period: N/A

Recommended Extension Award Amount: \$1,501,425

Recommended Extension Period: October 1, 2016 – December 31, 2016  
This is the first extension of the contract. The awardees have agreed to extend for an additional three (3) month period, by letter, on file.

Vendors Recommended for Contract Extension: Four (4)

Great Waste and Recycling Services, LLC  
Only Recycling, LLC  
Progressive Waste Solutions of Florida, Inc.  
Waste Management Inc. of Florida

Justification: It is considered to be in the best interest of the District to extend this contract for an additional three (3) month period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of July 2016, indicated an annual index increase of 0.8%. Staff has indicated satisfactory performance from the vendors and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the School Board.

Benchmark: Attempts were made to benchmark against the School Boards of Broward and Palm Beach Counties, however, the terms and conditions are not similar, so benchmarking could not be performed.
