CONTRACT EXTENSION SUMMARY

Contract Title: TELECOMMUNICATIONS SERVICE

Purpose of Contract: The purpose of this contract is to furnish, at firm unit prices, materials, installation and service for telephone service, for Miami-Dade County Public Schools, under the auspices of the Universal Service Fund (E-Rate), with a qualified telecommunications service provider who has been certified by the Public Service Commission and meets the requirements for E-Rate funding as a Common Carrier

Initial Award Amount: \$30,000,000

Initial Contract Award Period and Extension: July 1, 2013 – June 30, 2015
Two (2) years, with an option to extend for three (3) additional one (1) year periods, and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

Current Extension Amount: \$10,000,000

Current Extension Period: July 1, 2016 – June 30, 2017

Recommended Extension Award Amount: \$10,000,000

Recommended Extension Period: July 1, 2017 – June 30, 2018
This is the third extension of the contract. The awardee has agreed to extend for an additional one (1) year period, by letter, on file

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of November 2016, indicated an annual index increase of 1.7%. Staff has indicated satisfactory performance from the vendor and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the School Board.
