Contract No.: 14-038

Contract Title: ELEVATOR SERVICES CONTRACT

Board Meeting Date: October 14, 2015 – Agenda Item F-63

Purpose of Contract: The purpose of this ITB is to institute a continuing program of testing, inspection, maintenance and repair to provide necessary, systematic, periodic service, maintenance and repair of all of the elevators, wheelchair lifts, and/or dumbwaiters.

Initial Award Amount: \$1,200,000

Initial Contract Award Period and Extension: October 14, 2015 – October 13, 2017
Twenty-four (24) months, with an option to extend for three (3) additional one (1) year periods.

Current Extension Amount: N/A

Current Extension Period: N/A

Recommended Extension Award Amount: \$600,000

Recommended Extension Period: October 14, 2017 – October 13, 2018
This is the first extension of the contract. The awardee has agreed to extend for an additional one (1) year period, by letter, on file.

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from continuity of service, inasmuch as the Consumer Price Index (CPI), as of May 2017, indicated an annual index decrease of 0.1%. Staff has indicated satisfactory performance from the vendors and recommends extension. This extension is based on the terms and conditions contained in the original contract approved by the School Board.
