

Contract No.: 14-037

Contract Title: FULL SERVICE PLUMBING AND GENERAL REPAIRS

Board Meeting Date: October 14, 2015 – Agenda Item F-62

Purpose of Contract: The purpose of this ITB is to establish a pool of pre-approved vendors, to furnish all labor, supervision, equipment and materials necessary to perform any plumbing, general plumbing repairs and installations in schools and other facilities for The School Board of Miami-Dade County, Florida.

Initial Award Amount: \$650,000

Initial Contract Award Period and Extension: October 14, 2015 – October 13, 2016
Twelve (12) months, with an option to extend for four (4) additional one (1) year periods.

Current Extension Amount: 600,000

Current Extension Period: October 14, 2016 – October 13, 2017

Recommended Extension Award Amount: \$650,000

Recommended Extension Period: October 14, 2017 – October 13, 2018
This is the second extension of the contract. The awardee has agreed to extend for an additional one (1) year period, by letter, on file.

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from continuity of service, inasmuch as the Consumer Price Index (CPI), as of June 2017, indicated an annual index increase of 1.6%. extension. This extension is based on the terms and conditions contained in the original contract approved by the School Board.
