
SUBJECT: **SUPERINTENDENT'S EXTENSION OF CONTRACTS**

CONTRACT EXTENSION SUMMARY

Contract No.: **RFP-14-020-MT**

Contract Title: **TEENAGE PARENT PROGRAM (TAP) CHILDCARE SERVICES**

Board Meeting Date: September 30, 2015

Agenda Item: E-142

Purpose of Contract: The purpose of this contract is to select qualified and experienced agencies to facilitate the Teenage Parent Program (TAP) childcare services for The School Board of Miami-Dade County, Florida.

Initial Award Amount: \$1,000,000

Initial Contract Award Period and Extension: October 14, 2015 through October 13, 2016
One (1) year, with an option to extend for four (4) additional one (1) year period beyond the expiration date of the current contract period.

Current Extension Amount: \$1,000,000

Current Extension Period: October 14, 2017 through October 13, 2018

Recommended Extension Award Amount: \$1,000,000

Recommended Extension Period: October 14, 2018 through October 13, 2019
This is the third extension of the contract. The awardee has agreed to extend for an additional one (1) year period, by letter on file.

Vendors Recommended for Contract Extension: Two (2)



Cost Savings: No

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of December 2016, indicated an increase of 0.3%. Staff has indicated satisfactory performance from the vendor and recommends extension. This extension is based on the terms and conditions contained in the original contract approved by the School Board.

Benchmark: Attempts were made to benchmark against the School Boards of Broward and Palm Beach counties; however, the terms and conditions are not similar, so benchmarking could not be performed.
