

CONTRACT EXTENSION SUMMARY

Contract No.: **RFP-14-027-VF**

Contract Title: **COMPREHENSIVE ON-SITE HEALTH CARE SERVICES FOR STUDENTS ATTENDING CONTINUING OPPORTUNITIES FOR A PURPOSEFUL EDUCATION (C.O.P.E) CENTER NORTH**

Board Meeting Date: July 15, 2015 Agenda Item: E-141

Purpose of Contract: The purpose of this contract is to provide on-site comprehensive healthcare services to approximately 165 teen parents and their infants/ toddlers at COPE Center North, located at 9950 NW 19th Avenue, Miami, Florida 33147.

Initial Award Amount: \$220,000

Initial Contract Award Period and Extension: July 15, 2015 through July 14, 2017
Two (2) years, with an option to extend for three (3) additional one (1) year periods beyond the expiration date of the current contract period.

Current Extension Amount: \$55,000

Current Extension Period: July 15, 2018 through January 14, 2019

Recommended Extension Award Amount: \$55,000

Recommended Extension Period: January 15, 2019 through July 14, 2019
This is the third extension of the contract. The awardee has agreed to extend for an additional six (6) month period, by letter on file.

Vendors Recommended for Contract Extension: One (1)

Cost Savings: No

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of December 2016, indicated an increase of 0.3%. Staff has indicated satisfactory performance from the vendor and recommends extension. This extension is based on the terms and conditions contained in the original contract approved by the School Board.


