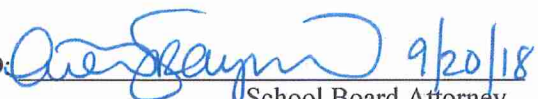
SUBJECT: **SUPERINTENDENT'S EXTENSION OF CONTRACTS**

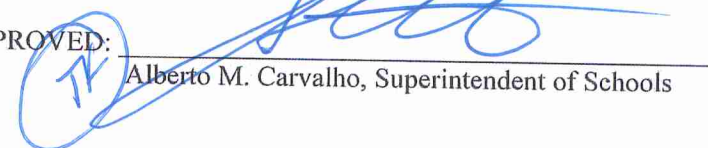

CONTRACT EXTENSION SUMMARY

Contract No.: RFP-14-043-VF

Contract Title: Inspection and Administrative Services for Elevator and Wheelchair Lifts

Board Meeting Date: October 14, 2015 Agenda Item: F-60

Purpose of Contract: The purpose of this contract is to obtain professional services of a certified agent or agency in the specific area of elevator and wheelchair lift inspection and certification. This service will also include periodic monitoring or quality control inspections of repairs performed by the elevator maintenance provider for The School Board of Miami-Dade County, Florida.

Initial Award Amount: \$120,000

Initial Contract Award Period and Extension: October 14, 2015 – October 13, 2016
Twelve (12) months, with an option to extend for four (4) additional one (1) year periods.

Current Extension Amount: \$120,000

Current Extension Period: October 14, 2017 - October 13, 2018

Recommended Extension Award Amount: \$120,000

Recommended Extension Period: October 14, 2018 – October 13, 2019
This is the second extension of the contract. The awardee has agreed to extend for an additional one (1) year period, by letter on file.

Vendors Recommended for Contract Extension: One (1)

Tower Elevator Corporation MBE

Cost Savings: N/A

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of June 2018, indicated an increase of 0.1%. Staff has indicated satisfactory performance from the vendor and recommends extension. This extension is based on the terms and conditions contained in the original contract approved by the School Board.

Benchmark: Attempts were made to benchmark against the School Boards of Broward and Palm Beach counties; however, the terms and conditions are not similar, so benchmarking could not be performed.
