

CONTRACT EXTENSION SUMMARY

Contract No.: **RFP-15-008-MT**

Contract Title: **CHARTER SCHOOL MONITORING SYSTEM**

Board Meeting Date: April 13, 2016 Agenda Item: E-141

Purpose of Contract: The purpose of this Request for Proposals (“RFP”) is to select qualified and experienced firms to assist The School Board of Miami-Dade County, Florida in the development and implementation of charter school system services individuals and/or organizations to provide Diversity Training services for District Staff.

Initial Award Amount: \$160,000

Initial Contract Award Period and Extension: April 13, 2016 through April 13, 2018
Two (2) years, with an option to extend for two (2) additional one (1) year period beyond the expiration date of the current contract period.

Current Extension Amount: \$80,000

Current Extension Period: April 13, 2018 through April 13, 2019

Recommended Extension Award Amount: \$80,000

Recommended Extension Period: April 13, 2019 through April 13, 2020
This is the second extension of the contract. The awardees have agreed to extend for an additional one (1) year period, by letter on file.
