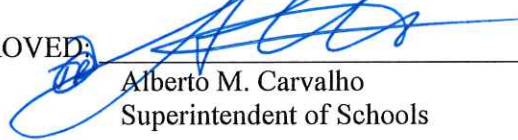
SUBJECT: **SUPERINTENDENT'S EXTENSION OF CONTRACTS**

Contract Title: **THIRD PARTY ADMINISTRATOR (TPA) FOR THE SELF-FUNDED WORKERS' COMPENSATION PROGRAM AND LIABILITY PROGRAM**

Purpose of Contract: The purpose of this contract is to select qualified and experienced vendor(s) to perform Workers' Compensation Claims Administration Services and Third Party Liability Claims Administration Services, for the The School Board of Miami-Dade County, Florida.

Initial Award Amount: \$5,275,000 per year

Initial Contract Award Period and Extension: July 1, 2015 through June 30, 2018
Three (3) years, with an option to extend for two (2) additional one (1) year period beyond the expiration date of the current contract period.

Current Extension Amount: \$5,275,000

Current Extension Period: July 1, 2018 through June 30, 2019

Recommended Extension Award Amount: \$5,275,000

Recommended Extension Period: July 1, 2019 through June 30, 2020
This is the second extension of the contract. The awardee has agreed to extend for an additional one (1) year period, by letter on file.
