
SUBJECT: **SUPERINTENDENT'S EXTENSION OF CONTRACTS**

## CONTRACT EXTENSION SUMMARY

Contract No.: RFP-15-082-YWP

Contract Title: Comprehensive On-Site Health Care Services for Students Attending Dorothy M. Wallace Continuing Opportunities for a Purposeful Education (C.O.P.E.) Center South

Board Meeting Date: June 21, 2017    Agenda Item: E-145

Purpose of Contract: The purpose of this contract is to provide on-site comprehensive health services to approximately 112 teen parents and their infants/toddlers at the Dorothy M. Wallace Continuing Opportunities for a Purposeful Education (C.O.P.E.) Center South. This program will serve teen parents in grades 6-12.

Initial Award Amount: \$324,000

Initial Contract Award Period and Extension: August 10, 2016 – August 09, 2018  
Two (2) years, with an option to extend for three (3) additional one (1) year periods.

Current Extension Amount: \$94,500

Current Extension Period: August 10, 2019 – August 9, 2020

Recommended Extension Award Amount: \$162,000

Recommended Extension Period: August 10, 2020 – August 09, 2021  
This is the third extension of the contract. The awardee has agreed to extend for an additional one-year period, by letter, on file.

Cost Savings: N/A


