CONTRACT EXTENSION SUMMARY

Contract No.: ITB-15-044-CV

Contract Title: Remanufactured Engines

Board Meeting Date: June 22, 2016 Agenda Item: E-144

Purpose of Contract: The purpose of this contract is to purchase, at firm unit prices, OEM Remanufactured Engines for The School Board of Miami-Dade County, Florida.

Initial Award Amount: \$700,000

Initial Contract Award Period and Extension: June 22, 2016 – June 21, 2018
Two (2) years, with an option to extend for three (3) additional one (1) year periods.

Current Extension Amount: \$350,000

Current Extension Period: June 22, 2019 – June 21, 2020

Recommended Extension Award Amount: \$350,000

Recommended Extension Period: June 22, 2020 – June 21, 2021
This is the third and final extension of the contract. The awardee has agreed to extend for an additional one-year period, by letter, on file.

Vendors Recommended for Contract Extension: one (1)

Jasper Engine Exchange, Inc. dba Jasper Engines & Transmissions

Cost Savings: N/A

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices and continuity of service, inasmuch as the Consumer Price Index (CPI), as of February 2020, indicated a decrease of 0.1% with an annual index of 2.3%. Staff has indicated satisfactory performance from the vendor and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the School Board.


