CONTRACT EXTENSION SUMMARY

Contract No.: ITB-16-006-CV

Contract Title: Pest Control Extermination and Removal Service

Board Meeting Date: April 5, 2017 Agenda Item: E-141

Purpose of Contract: The purpose of this contract is to establish a list of preapproved vendors, to furnish labor, supervision, equipment and materials necessary to perform pest control extermination and removal service.

Initial Award Amount: \$400,000

Initial Contract Award Period and Extension: April 5, 2017 – April 4, 2019
Two (2) years, with an option to extend for three (3) additional one (1) year periods.

Current Extension Amount: \$200,000

Current Extension Period: April 5, 2020 – April 4, 2021

Recommended Extension Award Amount: \$400,000

Recommended Extension Period: April 5, 2021 – April 4, 2022
This is the third and final extension of the contract. The awardees have agreed to extend for an additional one-year period, by letter, on file.

Vendors Recommended for Contract Extension: Four (4)

Cost Savings: N/A

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from continuity of service, inasmuch as the Consumer Price Index (CPI), as of January 2021, indicated an increase of 0.3% with an annual index of 2.3%. Staff has indicated satisfactory performance from the vendors and recommends extension. This extension is based on the terms, conditions and pricing contained in the original contract approved by the School Board.

Benchmark: Benchmarking was conducted against the School Board of Broward and Palm Beach Counties, Florida. However, since there were differences in the bid specifications, a price comparison could not be performed.
