Purpose of Contract: The purpose of this Request for Proposals (“RFP”) is to select an agency(ies) to deliver a wide range of professional development services to all non-public schools that have applied for services from the District under provisions of the Title II, Part A, Teacher and Principal Training and Recruiting Funds. This RFP required professional development services for the following three groups of participants: 1) Catholic schools represented by the Archdiocese of Miami; 2) Jewish schools represented by the Center for the Advancement of Jewish Education; and 3) Private schools not affiliated with the above (approximately 15 private, independent schools based on 2017-2018 totals).

Initial Award Amount: \$2,249,133

Three (3) years, with an option to extend for two (2) additional one (1) year periods.
