


SUBJECT: SUPERINTENDENT'S EXTENSION OF CONTRACTS

Purpose of Contract: The purpose of this Request for Proposals (RFP) is to determine qualified and experienced Community and Faith-Based Organizations capable of providing adult educational programs in conjunction with grant requirements. This RFP was released as a part 2 of the awarded E-141 item dated July 15, 2020 to increase the vendor pool for District coverage ensuring all areas are covered.
