
SUBJECT: SUPERINTENDENT'S EXTENSION OF CONTRACTS

Purpose of Contract: The purpose of this Invitation to Bid (ITB) is to establish a contract for the supply and installation of carpet tile, resilient floor tile and resilient sheet flooring, as needed, for Miami-Dade County Public Schools.
