
**SUBJECT:** SUPERINTENDENT'S EXTENSION OF CONTRACTS

Purpose of Contract: The purpose of this Invitation to Bid (ITB) is to select qualified professional firm(s) to provide speech and language pathology services and evaluations. Awarded firms will be required to participate in the Medicaid Certified School Match (Fee for Service Reimbursement) Program.

Initial Award Amount: \$15,000,000

Initial Contract Award Period and Extension: June 19, 2019 through June 18, 2022  
Three (3) years, with an option to extend for two (2) additional one (1) year periods.


